## DANGER

## PRECAUTIONS:

Keep container tightly closed. Ground and bond container and receiving equipment. Use explosion proof electrical, ventilating and lighting equipment. Use only non-sparking tools. Take precautionary measures against static discharge. Do not breathe mist or vapor. Wash hands and other exposed skin areas thoroughly after handling. Do not eat, drink or smoke when using this product. Use only outdoors or in a well-ventilated area. Avoid release to the environment. Wear protective gloves, protective clothing and eye protection. Store locked up in a well-ventilated place. Keep container tightly closed. Keep cool. Dispose of contents and containers in accordance with national and local regulations.

## FIRST AID:

Refer to Section 4 of the SDS. If skin irritation occurs or if eye irritation persists: Get medical attention. Take off immediately contaminated clothing and wash before reuse. In case of fire: Use water fog, foam, dry chemical or carbon dioxide for extinction. Collect spillage.
